Associate Diploma non-accredited commitment declaration form

This form must be completed and signed by all Associate Diploma non-accredited candidates and Mentors. Forms will be emailed early January 2018 to those currently enrolled.

Licentiate Diploma ruling for Part 2

Ruling for Part 2 Licentiate Diploma applications, specifically for those who have completed part 1 under the old rules and now wish to commence Part 2. The cost for Part 2 will be \$400.00. A 200 word synopsis is to be handed to the Mentor for approval before commencing the paper. Mentors must also sign off on papers before submitting to the National Office.

Candidates who are currently completing Part 2 on the old Licentiate Diploma system will have 2018 to complete the qualification or they revert to the new Rules and must restart.

Reprints of Examination Certificates

In 2017 we saw the introduction of a fee for reprinting examination certificates. This is to cover the costs incurred for the National Office's administrative services.

\$10.00 per certificate if a one off – includes postage

\$5.00 per certificate and \$5.00 postage if multiple certificates are required in one request.

Skirts in Examinations

In teachers own studio, use of skirts is optional, however in Centres you must follow the ruling of National Council as noted below.

YEAR	LEVEL	
From 2018	Grade 1 – 3	No skirts in Centre examinations
From 2018	Majors	No skirts in Centre examinations
From 2019	Grade 4	No skirts in Centre examinations
From 2020	Grade 4 and 5	No skirts in Centre examinations
From 2021	No skirts to be worn in any level for Centre Examinations	

Pre-Primary and Primary the rule remains unchanged i.e.: skirts to be worn.

Demi Pointe Shoes

Following from the Examiners meeting in July. Demi Pointe in examinations will be phased out in Majors from 1st January 2018 and to be replaced by either leather or canvas flats.

CUA40313 Certificate IV in Dance Teaching and Management course content

The elective unit TAEASS403B Participate in assessment validation in the Certificate IV accredited course was dropped and replaced with CUADLT401 - Document dance (Release 2). Information regarding this new elective will be made available through the National Office.

Advanced 2 Category B

The current regulations for Advanced 2 Category B states:

Advanced 2 - In individual circumstances there is provision for a teacher with physical limitations, holding the Licentiate qualification who wishes to do the Advanced 2 examination to produce 2 medical certificates to "allow them to bring in 2 students for them to teach exercises requested by the Examiner in place of them performing the exercises." This would be in the case of a candidate who had physical restrictions due to knee or hip surgery. (Regulations & Procedures for Cecchetti Ballet Australia ^{Inc.} revised Jan 2016 page 5 point 5)

This category has been removed.

Instead the candidate is to perform the steps themselves to the best of their ability, rather than teach students exercises as requested by the Examiner. This category will be known as Advanced 2 Category B Special. Effective 1st January 2018.

It is expected the Advanced 2 candidate undertaking this qualification is working towards their Fellowship.

With the application you must provide:

- 2 medical certificates, (2 separate practitioners, same practice is permitted)
- A letter from the Mentor confirming the Candidate is working towards their Fellowship.
